The SOFT President and Vice President each served one year terms, the Secretary served a two year term and the SOFT Directors Jenkins and Simonick each served three-year terms. The Society of Forensic Toxicologists will continue to be represented by Laurel Farrell as Treasurer and the following Directors: Bruce Goldberger and Graham Jones.

The 1998 SOFT Nominating Committee, composed of immediate past-president Joseph Saady, PH.D., DABFT (Chairman), William Anderson, Ph.D., DABFT, and Joseph Monforte, Ph.D., DABFT, present to the members of the Society of Forensic Toxicologists the following nominees for SOFT offices and directorships for the year 2000.

PRESIDENT - Robert Zettl, B.S., M.P.A: J. Robert Zettl retired in 1998 after 34 years with the State of Colorado, Department of Public Health and Environment, Division of Laboratories. During his employment he held various positions with the department, with the last 28 years devoted to the field of alcohol and drug toxicology. Mr. Zettl is currently employed as a consultant with Forensic Associates and is President and CEO of Forensic Alcohol Consultants, Inc. of Colorado, After receiving his BS from Pittsburgh State University (Kansas) in 1964. Mr. Zettl obtained a Masters in Public Administration from the University of Colorado in 1991. His professional activities include membership in numerous scientific and non-profit organizations, including SOFT, AAFS, SAT, SWAFS, CAT, NSC, NSC/COAAD, and NSC/HTSD. He is a past chairman of the NSC's Committee on Alcohol and Other Drugs, consultant to NHTSA, DOT regional workshop participant, CAP/FUDT and HHS/SAMHSA inspector, Borkenstein School Instructor, APRI instructor and has presented and published with emphasis on alcohol testing and training. Bob served SOFT as a Director for three years. Treasurer for two years, and currently is Vice President.

VICE PRESIDENT - Michael Smith, Ph.D., DABFT: Dr. Smith is a US Army Colonel and Chief Deputy Medical Examiner over the Forensic Toxicology Laboratories in the Office of the Armed Forces Medical Examiner, Washington, DC. He earned a bachelor's degree in chemistry from Kansas State Teachers College, Emporia, KS, and a Ph.D. in bioanalytical chemistry from Purdue University, W Lafayette, IN. Dr. Smith received Diplomate status from the American Board of Forensic Toxicology. Past professional positions include Director of Clinical Research at army medical centers and commander of the US Army Forensic Toxicology Drug Testing Laboratory that served the European Theater in the late 1980 Dr. Smith has 120 professional publications and abstracts and served as an expert witness in over 50 federal cases. The forensic toxicology laboratories he currently directs include the Department of Defense (DoD) Central Postmortem/Human Performance Laboratory, the DoD Testing Quality Control Laboratory, and the DoD Forensic Toxicology Research Branch. Dr. Smith has been a full member of SOFT since 1988, a Director from 1995 to 1997, and will complete his 2-year term as Secretary this year.

SECRETARY - Amanda Jenkins, Ph.D., D-ABC: Amanda Jenkins is currently the Chief Toxicologist for the office of the Cuyahoga County Coroner in Cleveland, Ohio, and also an Assistant Professor in the Dept. of Pathology at Case Western University School of Medicine. Dr. Jenkins received a B.S. in Biochemistry and Physiology from the University of Leeds, England; a M.S. in Forensic Science from Strathclyde University in Glasgow, Scotland; and a Ph.D. in Toxicology from the University of Maryland. ### DIRECTORS:

**Daniel Isenschmid, Ph.D., DABFT** (re-elect for 2 years to complete required 3-yr term): Dr. Isenschmid received a B.S. degree in Biology from Adelphi University and M.S. and Ph.D. degrees in pathology and forensic toxicology, respectively, from the University of Maryland at Baltimore. He is the Chief Toxicologist at the Office of the Wayne County Medical Examiner in Detroit, MI. He received the Irving Sunshine Award from the AAFS and was the 1998 Chairman of the Toxicology Section for the AAFS. His SOFT activities include assistant moderator (1990), Education Research Award Committee (1994-present), 1995 Meeting Committee, 1996 Meeting Workshop Committee and co-host for the 2002 SOFT Annual Meeting (Detroit). Dr. Isenschmid served as a SOFT Director from 1996-1998 and was elected to a "partial" 1-yr term (1999). If elected, he would extend his current term to the required 3-yr Directorship.

N.G.S. Rao, Ph.D., DABFT (elect for 3-year term): Subsequent to receiving his B.S., M.S., and B.Pharm. in India, Dr. Rao earned another M.S. (Industrial Pharmacy) from the St. Louis College of Pharmacy, St. Louis, MO, and his Ph.D. (Pharmaceutical Chemistry) from North Dakota State University, Fargo, ND. Dr. Rao has been chief of the Toxicology Bureau, Scientific Laboratory Division, for the New Mexico Department of Health (Albuquerque) since 1994. Previously, he held positions within the Office of the State Toxicologist in Fargo, ND. His other professional accomplishments include numerous academic positions, approximately 25 articles published as author or co-author, and certification as a Diplomate of the American Board of Forensic Toxicology. He is a member of AAFS (Fellow) and TIAFT as well as SOFT where he served diligently as co-host for the highly acclaimed 1998 SOFT/TIAFT Meeting in Albuquerque.

**Timothy Rohrig, Ph.D., DABFT** (elect for 3-year term): Dr. Rohrig is currently Director of Laboratories at the Center for Forensic Sciences, Onondaga County, Syracuse, NY, and a Clinical Assistant Professor of Pathology at SUNY Health Science Center at Syracuse. His previous experiences include Vice president and Director of Toxicology of Osborn Laboratories and Chief Toxicologist and Laboratory Director for the State of Oklahoma MEO. Dr. Rohrig holds a B.S. in Chemistry and a Ph.D. with an emphasis in Pharmacology/Toxicology, is an ABFT Diplomate, and has authored fifteen peer-reviewed articles as well as presented numerous papers. ### Annual Business Meeting Minutes of the Society Of Forensic Toxicologists, Inc.

### October 9, 1998

The Annual Business meeting of the Society of Forensic Toxicologists, Inc. was held on October 9, 1998 at the Hilton Hotel, Albuquerque, NM. President Joseph Saady called the meeting to order at 2:10 p.m. and requested that the Secretary establish a quorum. President Saady advised attendees to sign in and reminded those in attendance that only full members may vote. Upon a motion duly made, seconded and passed, the agenda was approved. By motion duly made, seconded and passed, the minutes of the annual business meeting of the Society of Forensic Toxicology of October 8, 1997 as published in ToxTalk were approved by acclamation.

#### President's Report: Joseph Saady, Ph.D.

President Saady outlined the accomplishments of S.O.F.T. in 1998. He reminded members that the annual meetings were a primary activity and pointed out that this year's meeting was extremely successful. S.O.F.T. has contracts for three future meetings: Puerto Rico 1999, Milwaukee 2000, and New Orleans 2001. President Saady emphasized that S.O.F.T. must be proactive in our ever-changing profession and provide national leadership to guide change. He identified our strength as the network of competent members who volunteer and "get the job done". He encouraged new members with an attitude of getting the job done to get involved in S.O.F.T. activities and bring new ideas. The President acknowledged that the Vision Working Group and Alcohol Testing Working Group were failures this year but pointed out that positive accomplishments for the year outweighed the failures.

#### Secretary's Report: Michael L. Smith, Ph.D.

Secretary Smith reported that S.O.F.T. approved 54 new members in 1998 bringing total membership to 556. He then read the names of all new members and asked them to stand. The other members welcomed them with applause.

#### Vice President's and Committee's Reports: Marilyn Huestis, Ph.D.

Vice President Huestis thanked committee chairs in advance for their dedication this past year. She then called on them in turn to give their reports.

A. By-laws Committee: Vice President Huestis relayed that Kurt Dubowski, Ph.D., chair, had produced a complete copy of the By-laws on paper and in electronic format. She indicated that there were no new By-laws this year. After being reviewed by the Board, a complete copy of all By-laws will be available to members.

B. Budget, Finance & Audit Committee: Vice President Huestis gave the report of Jim Valentour, Ph.D., chair, that stated that all accounting practices were properly conducted.

C. Nominating Committee: Vickie Watts, MS, chair, briefly outlined how nominees for office were selected. She stated that nominees were selected from those members who had a proven record of participation in S.O.F.T. activities, of understanding S.O.F.T. business and of accomplishing tasks. She then identified committee selected nominees: for President, Marilyn Huestis, Ph.D.; for Vice President, J. Robert Zettl, B.S., M.P.A.; for Treasurer, Laurel Farrell, B.A.; for Director, Graham Jones, Ph.D.; and for Director, one year only, Dan Isenschmid, Ph.D.

**D.** ToxTalk: Joe Monforte, Ph.D., editor, thanked Chip Walls, Vince Papa, Jim Wigmore, and Dan Isenschmid for their continuous contributions to ToxTalk. He stated that ToxTalk now has a circulation of over 600 then encouraged contributions of case reports and articles.

E. JAT Special Issue: Editor Dan Isenschmid, Ph.D., thanked all reviewers and the JAT staff for helping produce another outstanding issue. The Issue was available at this meeting and will be distributed to members who could not attend. At this time, Tinsley Preston, III, President of Preston Publications, awarded Dr. Isenschmid with a special plaque to commemorate his long hours and professional efforts.

F. ERA Committee: Vice President Huestis, speaking for Barbara Manno, Ph.D., chair, relayed that we had another rewarding year selecting four awardees: Rebecca Jufer, Jessica Long, Jeri Roper-Miller and Brad Hall. Their travel to this meeting, paid by the awards, allowed these young scientists to interact with members and increase their knowledge of forensic toxicology.

G. Meeting Resource Committee: Vice President Huestis asked meeting hosts in turn to give their reports.

Current Meeting: Ron Backer, Ph.D., one of the current meeting hosts, acknowledged the work of his S.O.F.T. co-host N.G.S. Rao, Ph.D. and TIAFT co-host Vina Spiehler, Ph.D. He described the meeting as very successful with over 670 registrants, over 300 being S.O.F.T. or TIAFT members.

1999 Meeting, San Juan, Puerto Rico: Host Flor Mattos, B.S., introduced Lyvia Alvarez, M.D., Executive Director and Medical Examiner, Institute of Forensic Sciences, San Juan, Puerto Rico, who presented a slide series that featured next year's meeting as a very professional gathering in a beautiful setting by the ocean.

2000 Meeting, Milwaukee, WI: Stephen Wong, Ph.D., meeting host, presented the President with a traditional cheese it, introduced his planning team by name, then showed a series of slides that described Milwaukee as a "best kept secret" place of beauty. He highlighted the riverwalks, brewery and performing arts center.

2001 Meeting, New Orleans: Leon Glass, Ph.D., substituting for host Pat Pizzo, B.S., who had to return to work, highlighted the meeting. A planning committee and hotel, the Radisson, have been selected. He mentioned that Ms Pizzo was considering a "Space Odyssey" theme for the meeting.

H. Forensic Toxicology Guidelines Committee: Graham Jones, Ph.D., chair, stated that the guidelines were posted in the S.O.F.T. web-site. The updated version will be published in ToxTalk and voted on at the next meeting.

I. Drugs & Driving Committee: H. Chip Walls, B.S., chair, informed the members that the benzodiazepine monograph and the Tox Bibliography are complete. Members who want copies of the monograph need to notify him via a form or Web-site. At this point, Mr. Walls presented Dr. Bill Anderson with a birthday cake and the members gave him a round of applause.

J. JCETT Committee Report: Ashraf Mozayani, Ph.D., chair, described the symposium for young scientists held the previous night and relayed that it was successful. She pointed out that JCETT had a web-site and encouraged all to visit it. She then asked that all members encourage young scientists to be active.

K. Policies & Procedures Committee: Bill Anderson, Ph.D., chair stated that the manual was complete. Next year his committee will have a database containing all policies and procedures and a mechanism to easily add new items.

L. Web-site Committee: Vice President Huestis, speaking for Bruce Goldberger, Ph.D., chair, pointed out the success and activity of the S.O.F.T. web-site with 17,000 hits since the April report.

At this point the Vice President asked if there were any other reports. Barry Logan, Ph.D., program coordinator for the 1999 AAFS Meeting in Orlando, FL, advertised the meeting and encouraged all to contribute and attend.

Robert Bost, Ph.D., past President, reminded members that the history of toxicology text edited by Irving Sunshine, Ph.D., entitled "Was It a Poisoning" was available to all members. Others may purchase the book at the registration desk. Dr. Bost also acknowledged the sponsors.

#### Treasurer's Report: J. Robert Zettl, B.S., M.P.A.

Treasurer Zettl reported that S.O.F.T. is in good standing. He enumerated S.O.F.T. supported gifts during the past , ear then informed the members that S.O.F.T. had a letter of agreement from the firm Sabatini & Wynn to continue as our accountants. The 1997 Income Tax return was filed without problems and the CPA audit found no irregularities. Treasurer Zettl then pointed out that a detailed transaction report was filed with the Board and a brief written Treasurer's report was available to members. The report listed \$6,738.95 in a checking account, \$146,075.77 in investments (\$70,439.52 of these are for the ERA Fund), \$25,000 in an emergency fund and \$6,989.38 in accrued interest. He also reminded the members that dues notices would be arriving next month.

#### Nominations from the Floor and Election of Officers:

Since no nominations were received from the floor, it was moved and seconded that all officers be elected as presented by the Nomination Committee. The newly elected 1999 S.O.F.T. officers and directors are as follows:

#### Old Business:

President Saady asked for any old business that needed to be addressed. Dr. Bost requested that S.O.F.T. reconsider moving its annual meeting dates so they do not cross fiscal years. He pointed out that some government employees could not attend due to problems with securing travel funds from two different fiscal years. President Saady acknowledged the problem, stated that the Board had considered the issue, but tabled the suggestion for consideration at a future business meeting since meeting dates are set through the year 2001.

There was no other old business from the members.

#### New Business:

President Saady asked for any new business. The following issues were raised and addressed:

Dr. Robertson informed the members that he and 17 other members comprised a working group that developed recommendations for the toxicological investigation of the crime of drug-facilitated sexual assault. The first product of this group is a manuscript entitled "Recommendations for the Toxicological Investigation of Drug-Facilitated Sexual Assault" to be published in an upcoming issue of the *Journal of Forensic Sciences*. Their next meeting will be during the AAFS Annual Meeting in February 1999. Anyone wanting information may contact Mark LeBeau, M.S., (202) 324-4329.

President Saady informed the members that the Board had discussed the problems surrounding the cancellation or the workshop entitled "Is Hair Analysis Racially Biased?" and that he had received many hallway comments about the cancellation indicating that members may have questions or comments. He asked if members had any questions or needed clarifications of actions taken by S.O.F.T. Dr. Stockham asked if the members could have some details about why the workshop was cancelled. President Saady gave a summary. The workshop was very controversial and some commercial enterprises were very upset that it was going to be held. SAMHSA, the sponsor, decided to cancel it. Dr. Osiewicz asked for the number of registrants, why S.O.F.T. was asked to sponsor, and who made the decision not to sponsor. Dr. Backer said there were 60-70 registrants. Along with President Saady he explained that after SAMHSA cancelled the workshop, S.O.F.T. had no other sponsor and there was not time for S.O.F.T. to organize the workshop so it was cancelled. Dr. Rollins pointed out that it was important that we, an organization dedicated to improving the skills and knowledge of members, not let commercial interests influence our exchange of scientific ideas. Mr. Robb asked if we had insurance that protected S.O.F.T. from lawsuits. President Saady said no. Mr. Walls asked directly if a commercial enterprise had threatened that they would sue S.O.F.T. if they sponsored the workshop. President Saady said that he had received nothing in writing but others said they had received such a threat. Mr. Walls asked further if the Board would respond to this possibility or similar problems surrounding S.O.F.T. taking a public position on a controversial issue. President Saady answered that the Board will investigate our need for legal representation for such matters. Dr. Rollins stated that most senior members saw this conflict coming and suggested that in the future S.O.F.T. step in early to avoid conflicts, for example, in this case they could have insisted early in the planning phase that the workshop have a less controversial title. Dr. Cone asked if S.O.F.T. had not always sponsored or at least sanctioned the workshops at its annual meetings. He continued to explain that this was his understanding when he participated in workshops and that he felt strongly that we should make efforts to reduce commercial influence. Vice President Huestis ended the discussion by reiterating that this particular workshop was difficult from the beginning because it had a controversial title and the proposed presenters held strongly opposing views. She stated that this could be a learning experience and the officers and Board have investigated ways to avoid similar problems in the future. She also assured the members that the Board had pledged not to let commercial enterprises dictate the science we present for education.

Dr. Cone pointed out that the timing of abstracts for S.O.F.T. meetings overlapped the AAFS meeting submissi dates and reduced support for the AAFS meeting. Several members agreed and pointed out that the deadline of June ... 1998, established by the Board, was extended to July placing it too close to the August 1, 1998 deadline for AAFS. They suggested that meeting planners not extend the deadline in the future.

#### Awards and Recognition:

President Saady thanked Mr. Tinsley Preston for publishing another excellent Special Issue of the Journal of Analytical Toxicology.

President Saady thanked Lisa O'Dell for her hard work getting vendors to attend and sponsor functions during the meeting. He stated that her gift would be sent to her since she had already departed.

President Saady then acknowledged the hard work of the Officers and Board. Official plaques of appreciation for outstanding service were presented to Marilyn Huestis, Ph.D., Vice President 1998, J. Robert Zettl, B.S., M.P.A., Treasurer 1997-98, and Laurel Farrell, B.S., Director 1996-1998.

The members acknowledged Drs. Backer, Rao, and Spiehler for hosting a very successful annual meeting. President Saady presented them each with a commemorative plate and coffee mug designed and crafted by a southwestern artist.

Vice President Huestis presented President Saady with a commemorative plate and mug and on behalf of the members thanked him for his past year of service to the society.

The newly elected President Huestis closed the meeting with important remarks to the members. She reminded everyone that S.O.F.T. is an informal organization that strives to make members feel welcome and encourages the sharing of new ideas. President Huestis requested that we actively continue this tradition; e-mail new ideas to officers and the Board, help plan workshops, send your best research findings to the S.O.F.T. Special Issue editor Dr. Goldberger (abstract and manuscript deadlines of Mar 8 and Mar 22, 1999, respectively).

Adjournment: The meeting was adjourned at 3:37 pm.

# **BYLAWS AMENDMENTS TO BE PRESENTED AT ANNUAL MEETING**

Some of the changes are simply corrections in grammar or reflect current phraseology (such as "unfinished" rather than "old" siness). The new "Order of Business" will reflect how SOFT actually conducts its Annual Business Meeting. A proposed change ander "Membership Qualifications" clarifies educational requirements for membership. The amendments to "Termination o Membership" clarifies the procedure by which a member may request termination and deletes "conduct contrary to the public interest" as a cause for censure or membership termination. Item A under "Duties of the Board of Directors" will require approval of any expense over \$5,000. This amount would be increased from the current \$1,000 limit.

The proposed amendments, provided by Secretary Michael Smith, are presented below. A copy of the Bylaws, with approved amendments, will be included in the 2000 SOFT Membership Directory.

#### PROPOSED AMENDMENTS TO THE BYLAWS

Subject to approval at the 1999 SOFT Annual Business Meeting

CHAPTER I. NAME AND OBJECTIVE Section 2. Objectives D. Provide a forum for the discussion and exchange of professional experiences between forensic toxicologists, and among forensic toxicologists and others engaged in the administration of justice, in other governmental functions, and in [other] allied fields.

CHAPTER II. MEMBERSHIP Section 1. Qualifications B. Applicants must have the following educational degrees in a natural science and experience: Ph.D. and 2 years experience in forensic toxicology M.S. and 4 years . . . B.S. or B.A. and 6 years . . .

Section 3. Termination of Membership A. Membership in SOFT may be terminated by written notification from the member to the Secretary or the Secretary's designee.

C. # CASE NOTES: A Report of Four Elevated Pseudoephedrine Concentrations in Pediatric Cases

Therapeutic drug concentration ranges are typically determined from data generated by pharmacokinetic studies in adult populations. It is well known that due to the immaturity of enzyme systems and other pharmacokinetic and pharmacodynamic parameters, the response to a drug may differ in the pediatric population. Further, it is reasonable to assume that the toxic and lethal concentrations for the pediatric population may be different from the general adult population.

Expected pseudoephedrine concentrations following chronic administration of 360-mg pseudoephedrine daily yielded steady state plasma concentrations averaging between 0.50 to 0.64 mg/L (Baselt 1999).

Few cases of pseudoephedrine in the pediatric population have been reported. Baselt reports where a two year old child was found dead after reportedly ingesting at least 420 mg of pseudoephedrine and had a post mortem blood concentration of 66 mg/L (Baselt 1999). Hanzlick (1995) reports a series of 15 infants whose pseudoephedrine concentrations ranged from 0.07 to 13.0 mg/L (average of 3.55 mg/L). In one case pseudoephedrine/carbinoxamine poisoning was listed as the cause of death (the pseudoephedrine concentration was 13 mg/L, carbinoxamine conc. was 0.27 mg/L). In four of these cases the medical examiner was suspicious of pseudoephedrine toxicity (pseudoephedrine concentrations of 2.3, 3.4, 6.2, and 1.8 mg/L).

I report here a series of four pediatric cases that were submitted to National Medical Services for toxicological analysis. The data is listed in table 1. None of the case histories identified the anatomical source of the blood; however, in case 4, other blood tests were preformed using heart blood. This author infers that this was also the source of blood used for toxicological analysis. In each of the cases presented the pseudoephedrine was the only drug that was present in significantly elevated concentrations. These results appear to be consistent with other reported pediatric blood levels.

Unfortunately only scant histories were provided in three of these cases (2 - 4) and no history was given in the other. As a result it is unknown what role the elevated pseudoephedrine findings played in the terminal events of these children. It is also unknown if either the cause or manner of death was amended as a result of these findings.

To date little information exists regarding pediatric post mortem forensic toxicology. It is hoped that these four cas, will contribute to the understanding of pediatric physiology and pharmacology.

# EXTRACTIONS

"Use Of NitroLingual Spray And Alcohol Breath Testing," from Toxi-Logic, A Publication of the Toxicology Section of the Canadian Society of Forensic Science, Vol 24, No 1, June 1999.

Pursuant to a request from a Qualified Technician, tests were performed to determine the effect, if any, of NitroLingual Spray use on the results of an alcohol breath test when the spray is used by a subject immediately prior to providing a breath sample. Each metered dose of NitroLingual Pumpspray contains 0.4 mg of nitroglycerin in an oily flavored solution. The solution also contains dichlorodifluoromethane, dichlorotetrafluoromethane, ether, menthol oil, vegetable oil, menthol and ethyl alcohol.

Tests were made using a Breathalyzer 900A (chemical detection system) and an Intoxilyzer 5000C (infrared detection system) instrument. Four volunteer subjects (1 female, 3 male) were used - two were determined to be alcohol free prior to the tests and two had consumed some beer prior to the tests. Only the results of the two subjects who had not consumed alcohol and tested negative prior to the experiment will be summarized.

Immediately following dosing, subjects A and B recorded alcohol concentrations of .170% and .300%, respectively, on the Breathalyzer 900A. On the Intoxilyzer 5000C Instrument, an "invalid sample" result was obtained with subject A immediately following dosing, and a .139% alcohol concentration was obtained for subject B immediately following dosing. After 5 minutes following dosing no measurable alcohol was recorded for subjects A and B on the Breathalyzer 900A device and low concentrations (0.009% and 0.010%) were recorded on the Intoxilyzer 5000C Instrument 5 minutes following dosing.

As expected, the only effect of the Nitrolingual spray on the breath tests results was the "mouth effect" of the 20% alcohol in the preparation. The effect disappeared within 5-6 minutes.

# "DRUGS IN THE NEWS"

#### "Positive Drug Findings at The Pan American Games"

The Arizona Republic reported that Cuban high jumper Javier Sotomayor forfeited a gold medal because he tested positive for cocaine at the recent Pan Am games in Winnepeg. Sotomayor, the only athlete ever to jump eight feet, is expected to be suspended for two years which will prevent him from competing in the 2000 Olympics. The positive finding in Sotomayor is being called the biggest track and field scandal since Ben Johnson tested positive for steroids at the 1988 Olympics.

It was the third time a gold medal has been stripped for a positive drug test. Juana Rosario Arrendal of the Dominican Republic lost her high-jump gold for testing positive for steroids and the Canadian men's roller hockey team lost its gold because Steve Vezina tested positive for stimulants, as well as a steroid.

#### "Methamphetamine Raids - A Different Perspective"

Methamphetamine has been reported to be the biggest drug problem in Arizona. Recently, estimated costs for a raid were published in the AZ Republic. The following breakdown was given: Salaries - \$10,000 (about 30 officers are needed including such peripheral personnel as firefighters at the scene, officers to secure the boundaries and bomb squads in case of

trap); Officer training - initially, \$2,500 each (officers become certified by attending a one-week training course in VA and ust be recertified every two years at a cost of \$2,000, each); Physicals - \$400 (cost of an annual physical); Equipment -

\$5,000 per agent (includes an agent's reusable Nomex suit, boots and self-contained breathing apparatus); Disposable gear -\$100 per agent per lab ( about 15 officers must be equipped with disposable rubber gloves, boots and coveralls); Prosecution - the AZ Attorney General's Office employs two full-time prosecutors who handle most cases.

# WORKSHOP PROGRAM ABSTRACTS

### WORKSHOP #1

### Drugs, Driving, and Traffic Safety: Update Sunday, October 10, 1999 8:00 a.m. – 5:30 p.m. Chip Walls, Moderator

A problem familiar to all of us in the forensic toxicology field...drug impaired driving. Solutions, methods of detection, something new and something old will be discussed. An update will be given on analytical methods currently used by toxicology labs supporting DRE programs. Methods that are suitable for detection and quantification of low concentrations of drug in small samples of blood or urine will be also discussed in detail.

How do people act under the influence of certain drugs commonly found in DUI/DWI cases? Learn the pharmacology and toxicology as they relate to human psychomotor performance. Lastly, and very integral to our job, is the role we play as forensic experts, and our interaction with the prosecution.

An experienced prosecutor will provide an overview of the key elements in a criminal DUI/DWI case, they will show the link between the lab, police and court which puts the case together. The ultimate goal is keeping the impaired driver off the road.

### WORKSHOP #2 Forensic Urine Drug Testing: Issues in Puerto Rico (To be conducted in Spanish) Sunday, October 10, 1999 8:00 a.m. – 12:00 p.m. Luz E. Droz, B.S., Moderator

One year after the new law enforcing workplace drug testing in public and private agencies, many issues have to be addressed. This workshop will address those issues and will help you professionals in the field to cope with the issues related to forensic urine drug testing.

### WORKSHOP #3 Pathology for Toxicologists Sunday, October 10, 1999 1:30 p.m. – 5:30 p.m. Steven B. Karch, M.D., Moderator

This workshop is designed to provide toxicologists, particularly those who teach medical and graduate students, an overview of the anatomic changes seen in most common types of poisonings. Some drugs produce recognizable patterns of tissue injury. These changes are familiar to pathologists, but not to toxicologists. The first portion of the workshop will be devoted to the pathology of drug abuse, with special emphasis on the vascular and neuropathology of cocaine and methamphetamine. The microscopic alterations seen in myocardial infarction, coronary artery disease, myocardial fibrosis, myocarditis, cardiomyopathy and aortic dissection, and excited delirium will be reviewed.

The pathology of opiate toxicity will also be examined, with special attention to changes in the liver and lungs, and to the types of tissue injury produced by different sorts of drug adulterants. Time permitting, the

remainder of the session will be devoted to a review of common drug poisonings; the liver injuries associated with acetaminophen and aspirin poisoning (Reyes syndrome), the renal changes associated with ethylene glycol, and the lung injuries associated with paraquat and diphenhydramine will be illustrated.

### WORKSHOP #4 Ion Trap Users Workshop Monday, October 10, 1999 Dave Johnson, Moderator

1:30 p.m. - 5:30 p.m.

This workshop will provide a practical review of internal ionization ion trap GC/MS. Presentations will detail applications of advanced ion trap technology with an emphasis on operational considerations.

Following the presentations, we will have a panel discussion to provide an open exchange of analytical ideas. This workshop will be valuable for users of ion trap GC/MS in addition to individuals interested in learning about applications of the technology.

### WORKSHOP #5 Pharmacology Reviews I: Selected New Drugs Monday, October 10, 1999 8:00 a.m. – 12:00 p.m. Lionel Raymon, Ph.D., Moderator

In recent years, knowledge of toxico-kinetics and dynamics has soared. With the recent advent of new drugs, often with very specific molecular mechanism of action, the forensic toxicologist is facing new challenges, not only analytical, but also interpretative. A strong knowledge of pharmacology is necessary to interpret data generated by forensic analyses.

The workshop will review the pharmacology underlying new drugs selected from forensically relevant classes. A general section on drug interactions through metabolism will review medically relevant cytochrome P450 systems, polymorphisms, induction and inhibition of this important biotransformation system and newer members of the flavin containing monooxygenases (FMO) system. Genotyping techniques will be presented.

This introduction to drug interactions will be followed by three hour long sessions covering: 1) the pharmacology of amine neurotransmitter degradative pathways, with the specific example of the new drug **moclobemide**, a reversible MAO inhibitor; 2) the pharmacology of GABA receptor, with an emphasis on allosteric modulation through the benzodiazepine receptors; illustration will review the new drug **zolpidem**; 3) the intricate pharmacology of dopamine/serotonin systems with the new atypical antipsychotic **quetiapine**.

### WORKSHOP #6 Investigation of Drug Facilitated Sexual Battery Monday, October 11, 1999 1:30 p.m. – 5:30 p.m. Laureen Marinetti-Sheff

The incapacitation of a chosen victim or victims by the use of ethanol alone or in combination with other drugs is not a new phenomenon. This idea has been used to facilitate robbery, kidnapping and more recently sexual assault.

The workshop will focus on various areas important to the detection and prosecution of drug facilitated assault. Discussion on the various drugs involved, their pharmacology, trends across the United States and Canada, laboratory analyses, proper and timely specimen collection and prosecution strategies will be covered. This workshop will appeal to those in forensic, clinical and research laboratories as well as those in law enforcement.


